## Zakres tematyczny

1. Working on particular parts of the theoretical work, consistent with the earlier theoretical assumptions – reporting the earlier adopted assumptions and discussion on them.
2. Transformation of theoretical assumptions into empirical research, the choice of specific research methods and techniques-methodological assumptions – discussion on the correctness of the chosen: research aims, main problem, detailed problems, hypotheses, indicators and variables.
3. Giving the final shape of the methodological part.
4. Conducting the pilot studies.
